Sister Cities Newport News (SCNN) invites you to participate in our 3<sup>rd</sup> Annual German Christmas Market or **WEIHNACHTSMARKT**. The market is located in the retail area of City Center, Oyster Point. **Vendor spaces are limited**. Vendors will be selected to ensure a variety of products, with preference given to handmade items. SCNN is responsible for beer & wine sales on site. This event is hosted by Sister Cities of Newport News and City Center at Oyster Point and is not an official event of the City of Newport News.

## **Vendor Rules:**

- 1. The German Market is a rain or shine event.
- 2. Vendors will be **provided** a 10'x10' space with a **white tent and string lighting**.
- 3. All tents are pre-lit in the same manner. Electrical service is limited. If you need electricity, please indicate so in your application. No generators are permitted in booths.
- 4. Vendors should provide tables, chairs and display racks for their products.
- 5. Vendor parking is available in the parking garages at no fee.
- 6. Vendors are expected to display items appropriate for the Christmas theme.
- 7. Vendors must operate for the entire length of the market (3-9 pm on both days).
- 8. No heating units of any type may be used in booths.
- 9. Vendor assignments will be made by SCNN.
- 10. Vendors will have access to the restrooms in a nearby, vacant store front on Mariners Row and can access wall plugs for charging phones etc.
- 11. Vendors must dispose of their trash in the dumpster, not in the market trash cans.
- 12. Tents will remain in place overnight. Security will be provided overnight. Each vendor is encouraged to decide for themselves if they want to remove inventory.
- 13. Approved vendors <u>must</u> provide a Certificate of Insurance (COI) listing "CCOP, LLC c/o Colliers, P.O. Box 13470, Richmond, VA 23225 and SCNN, Inc. P.O. Box 120504,NN 23612-0504)" as additionally insured. If you need assistance in securing an appropriate policy, please reach out to Sister Cities for assistance.
- 14. A \$40 non-refundable fee is required from all approved vendors.

**NOTE:** Saturday night's market coincides with the City of Newport News' "NLightN" tree lighting at the City Center Fountain but is a different event sponsored by the City NN. The City's event will have a limited number of vendors, food trucks and activities. The Tree lighting is scheduled for 7 pm.
